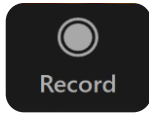

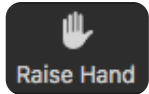

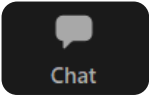

## Assumptions for the following conversation

- We will only be discussing the framework elements related to GHG metrics
  - Other metrics are relevant to corporate GHG reporting and we will consider those once we have aligned on a single framework for recommendation to the ISB
- Until the TWG finalizes relevant terms and definitions we will use the following working definitions:
  - **Physical Inventory** - A quantitative list of an entity's emissions, removals and other metrics over time occurring within the inventory boundary resulting from the physical flow of goods and services in their value chain.
  - **Contractual Inventory** - A quantitative list of an entity's emissions, removals and other metrics over time occurring within the inventory boundary resulting from the contractual claims to attributes of goods and services in their value chain.
  - **Impact Statements** – A disclosure of GHG metrics related to a reporting entity's actions or investments regardless of boundary calculated using consequential accounting methods.
  - **Beyond Inventory** - Emissions metrics and other values related to activities or impacts located outside of a reporting entity's inventory boundary.

## Physical Inventory

- In a majority of the submitted proposals, the physical inventory was an area of alignment

- Example language (from LSRS interim requirement): "To account for emissions, removals and other metrics at various spatial scales, companies must demonstrate they have physical traceability to relevant lands within their value chain, which may vary by activity and/or product type"

## Discussion Questions

Should we be developing a framework that provides guidance for existing market mechanisms or that consolidates the market into a concise, standardized approach?

Can the same goals be achieved with fewer approaches/reporting elements?

- To keep in mind as you answer:
  - The role of GHG Protocol in providing standardized approaches to corporate GHG accounting and reporting
  - The priority use case of each proposed statement
  - The existing programmatic ecosystem in relation to actions and market instruments

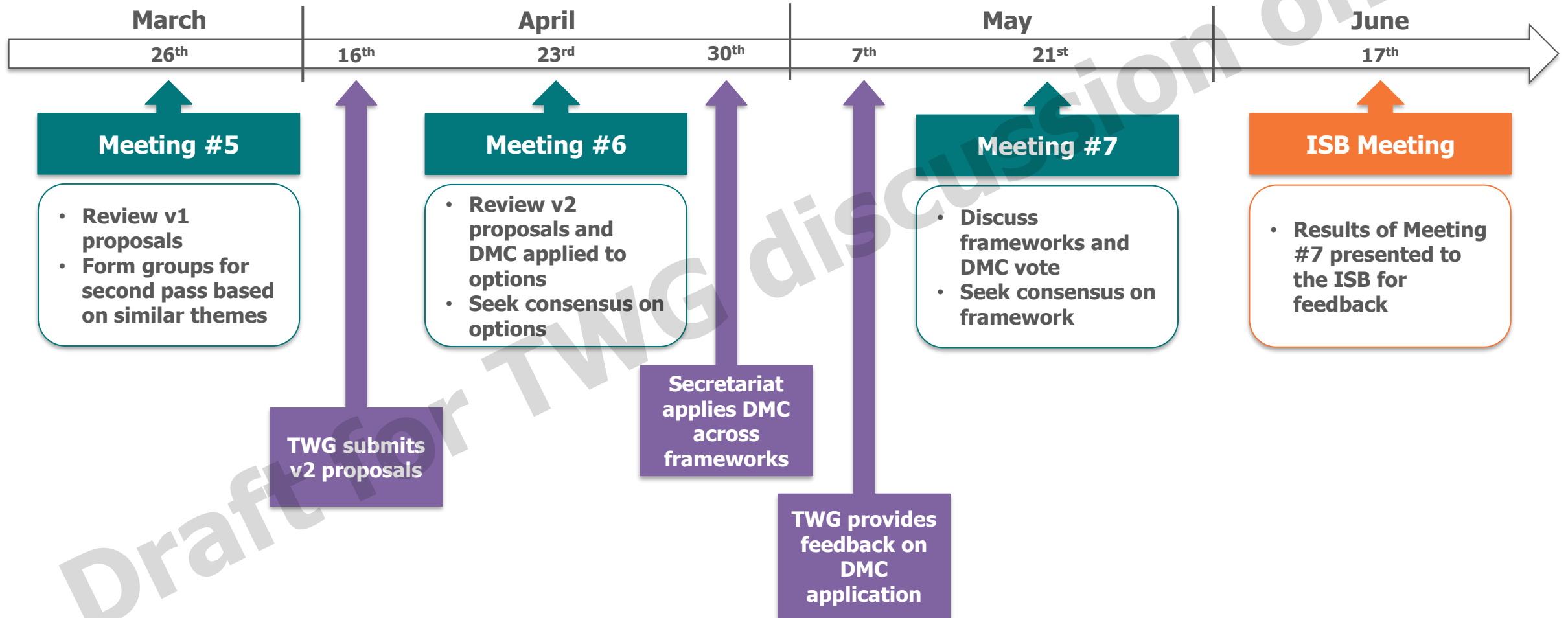
